



**The fund was launched by Phil Hope, Minister of State for Care Services on the 13 December 2009**

He said: "Volunteers do an amazing job and are vital to the lifeblood of the NHS and social care services. This new funding system offers more scope for national projects in areas such as obesity, smoking and young people's health. It will make our money worker harder by opening up funding opportunities to more organisations and systematically embedding volunteering in health and social care by supporting projects and their organisations to forge partnerships with commissioners and local statutory organisations."

**HSCVF Support Package**

The new fund is innovative in that it delivers not just grant but a whole support package for the health and social care volunteering sector.

- An organisation diagnostic – a facilitated session using an Organisation Diagnostic Tool (ODT) that aims to bring about organisational change through a review of the organisation's performance and identification of potential improvements.
- Support consultancy - where project managers can discuss various aspects of project delivery depending on their needs. There is no set agenda. Delivery is tailored to each organisation.
- Action Learning Networks – 5 workshops (accredited by the Institute of Leadership and Management) designed to establish projects as robust / fundable initiatives.
- Training - on volunteer management that includes volunteer selection, matching volunteers' needs to roles, supervision, volunteer pathways to employment, dealing with difficult volunteers, retention and recognising volunteers and their contributions.
- The opportunity to take part in an online forum - a virtual discussion portal.

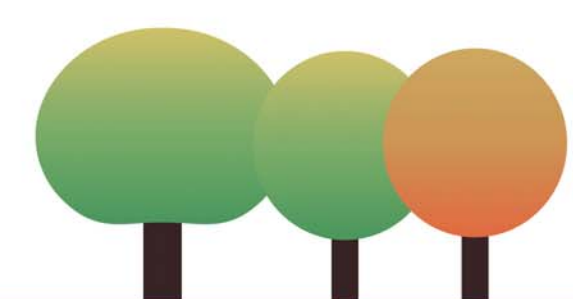
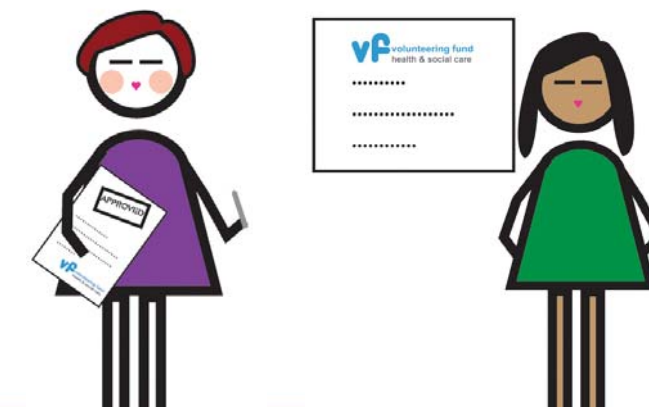

# 2010- Launching our first grant schemes.

## This year sees the first local and national grant scheme!

**Local grant scheme** – for locally constituted Voluntary Sector organisations supporting volunteering. Priority is given to projects focused on local health, public health and social care needs.

**National grant scheme** – for national organisations / partnerships with national reach. Successful projects will deliver strategic or developmental volunteering projects in the health, public health and social care sector.

## Local Grant Scheme key facts 2010

- We hold 7 pre-application events across England.
- We receive a total of 232 applications to the fund from across England.
- A total of £550,000 is offered to 43 successful local voluntary sector organisations.



## Snapshot of the Support Package 2010

- 61 delegates attended the first Action Learning Network

Annual report celebrates the Fund's achievements and the programme's outcomes



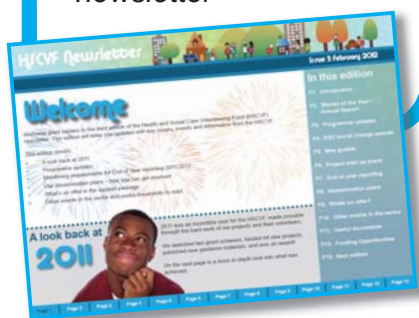
### December

### April

Second local grant scheme launched on the 6th April 2011. In total:

- 984 organisations registered their interest in applying
- 794 organisations who registered were eligible to apply
- 423 organisations complete an application

### May

The first evaluation of the HSCVF activity. Survey respondents are really positive about the support provided by the HSCVF team, the online systems and the support package. This is the first evidence that the support package is really valuable to the sector.

### October

Funding announced for local grant scheme. 51 local projects funded.

These projects have proven their ability to deliver local health and social care projects alongside statutory agencies, and are addressing health inequalities and supporting social care delivery through volunteering.

### October

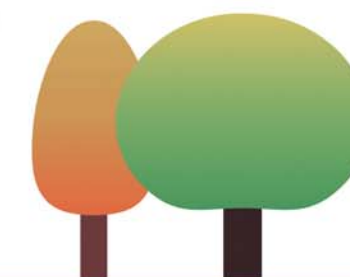
Launch second round of the national grant scheme.

### Celebrating HSCVF Conference

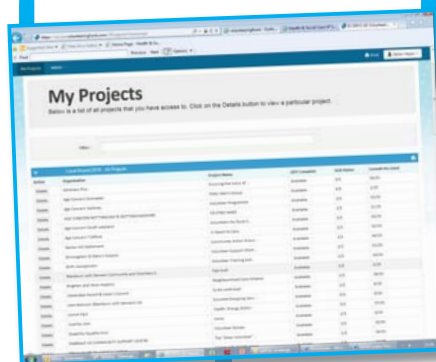

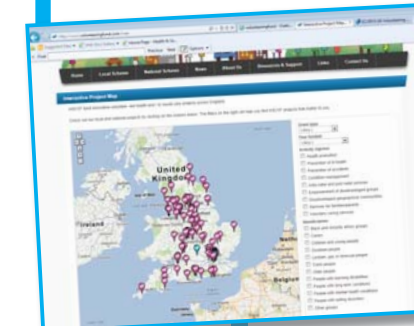
